1) Overview:

The Lithium test was originally scheduled as an optional 'multipurpose' measure to track all medications in a single application. Following review with clinicians and users the project has decided to limit ECH scope to a single 'measure' application to communicate lithium values to patients and potentially be included it into their life chart.

Following the ECH project this measure will be upgraded to be an 'editable' measure that clinical organisations can customise to communicate any test results.

2) Availability and Deployment

2.1. As per Measures - Common Functional specification

This measure shall be available on all portals from the WT master library and importable into 'life charts' as per D1.2.13A – Common – Measures Functional specification.

2.2. Specific Deployment limitations:

This measure can only be accessed and deployed onto Homepads by authorised users of the clinical care portal.

2.3. Availability limitations

- 2.3.1. Homepad users will only have viewing and sharing permissions.
- 2.3.2. Only users of the clinical care portal will be given permission to log readings and remind homepad users to a new reading.

4) Basic functionality.

4.1. Common behaviour

Unless specified otherwise in this document, the measure will behave as specified in D1.2.13A – Common – Measures Functional specification.

4.2. Name:

4.2.1. ECH specification: lithium test

4.2.2. Post ECH: User selected name

All measures allow CMP owners, but not HP service users to customise measure names. For activities, this ability will be offered to all users once the measure is deployed the CMP or HP. The customisation settings are part of the service user's record. (this is only available to paid users).

4.3. Units

4.3.1. ECH specification

4.3.2. Post ECH: user selected units

Users will be given the option of selecting the units in which activity will be measured. The aim is to connect 'measurability' with tracking. E.g. measure 'walks' not 'distance'.

4.4. Alerts

No automatic alerts will be set - Clinicians can, at their discretion, send a message explaining results.

4.5. Set user notifications

Only clinical care portal users will be able to trigger an automatic notification to inform users that their test results have been updated.

7.1.2. Main graph

This will display 2 line graphs on a common scale

7.1.2.1. X = axis

Time with the selected period shown = 'full width' where this = std level 1 page with 'next' and 'previous' level 1 horizontal scroll control default is 'current' time period. 'sub - time interval periods are clearly labelled

7.1.2.2. Y axis

'Number of units' at a scale where 'full height value = goal or max value whichever is greater.

Legend display taken from 'settings'

Goal level clearly displayed

10 % completion sub intervals on the vertical

7.1.2.3. Data points

Each reading is positioned in X at 'time stamp' and in Y as (total at previous reading + new units added at reading). New reading is joined to previous by a linear fit graph.

7.1.2.4. Thresholds (not for ECH)

Horizontal lines define 'zones' below threshold levels.

7.1.2.5. X axis displays. Default period is 'current'

7.1.2.6. X scales:

7.1.2.7. Week View (common with other calendar scales)'Full width = 1 weekMajor dividers as 7 even days with full name of days in between.

7.1.2.8. Month View (common with other calendar scales)
Default = current period
'Full width = 31 days
Major dividers at start of weeks
Minor dividers as days

7.1.2.9. Year view (common with other calendar scales)
Default = current period
'Full width = 12 months
Major dividers at start of months
Month names between dividers

Shows period from start to goal full width X axis divided into 10% interim milestones actual dates calculated as placed next to bold dividers for 20% 50% 80% milestones
